Our primary focus lies in the trading bots that we have developed in-house, which allow us to streamline cryptocurrency transactions effectively. We also engage with Maximum Extractable Value (MEV) bots that employ unique transaction strategies like the "sandwich attack." This approach involves executing smaller transactions surrounding a larger one to capitalize on fluctuations in the market, thereby generating profit.

OUR COMPANY'S MAIN PROFIT MAKING TOOLS – MEV BOTS

Here ' show the sandwich attack works:

Back-running: After the original user has bought or sold the token at the higher price, the bot quickly sells the tokens it bought at the increased price, realizing a profit.

The bot actually "sandwiches" the original user's transaction: it buys first and then sells, taking advantage of the price change it caused itself.

In summary, MEV bots are designed to take maximum advantage of the opportunities that arise from manipulating the order of transactions on the blockchain.

MEV bots (Maximum Extractable Value bots) are automated trading algorithms that try to extract as much profit as possible from transactions running on blockchains by interfering with their order. MEV means how much extra value a miner, validator, or merchant can "squeeze out" within a block by manipulating transactions, such as reordering them, front-running them, or performing sandwich attacks.

A sandwich attack is a common strategy used by MEV bots on decentralized exchanges (DEXs) such as Uniswap. This attack takes advantage of transaction transparency and the fact that transactions on the blockchain can be predicted before they are executed.

Forward Detection: The MEV bot monitors the blockchain and when it sees a major buy or sell transaction that is expected to significantly change the price of a token, it reacts immediately.

Front-running: The bot inserts its own transaction before the original user's, where it buys from the same token. This bot's transaction increases the price of the token.

Executing the original transaction: The original user's transaction is now done at the increased price that the bot manipulated.
